

Dear Comm Kids Families,

We are absolutely thrilled to have you this year as part of our Comm Kids Program! As you can imagine, with the current Covid-19 situation, we are taking every precaution necessary to keep you all safe and healthy following guidance from OCDEL as well as the CDC guidelines.

While attending any Comm Kids program at the Waverly Community House, we ask that Comm Kids and their families please abide by the following regulations to ensure that we all have a fun and successful school year. Please initial next to each individual item.

1. _____ I will not send my child to Comm Kids if they are exhibiting any sign or symptom of COVID-19. I understand that my child must be fever free for at least 24 hours prior to returning to Comm Kids.
2. _____ Should my child or anyone else in my home test positive for COVID-19, I will notify Comm Kids immediately. My child will be kept home for the appropriate quarantine period (14 days)/ will not return until all household members have recovered and are no longer contagious.
3. _____ I agree that should I take my child outside of the area to another part of the state, or to any of the states deemed high risk, that I will have my child quarantined for at least 14 days prior to returning to Comm Kids.
4. _____ I understand that should I be found to have knowingly sent my child to Comm Kids while he or she is exhibiting symptoms of COVID-19, in the home with someone who has tested positive for COVID-19 or is waiting on test results/waiting on test results him or herself, or has gone to a high risk area without quarantining, Comm Kids reserves the right to dismiss my child from the program.
5. _____ I will make sure that my child comes equipped with a face mask daily. I understand that my child will not obtain entry to Comm Kids without one.
6. _____ I will make sure that my child does not bring any personal belongings with them to Comm Kids other than those specifically specified by his or her teacher. This includes, toys, electronics, etc.
7. _____ I understand that in order for my child to attend Comm Kids, I must fill out to completion all necessary enrollment paperwork and permissions. I am aware that should I fail to do this upon three warnings from Comm Kids, that Comm Kids has the right to dismiss my child from the program.
8. _____ I am aware that payment must be made in full when it is due. I understand that should I fail to make a payment repeatedly (without making other arrangements with the Comm Kids Director if needed) that Comm Kids has the right to dismiss my child.
9. _____ I agree to abide by the Comm Kids Code of Conduct found in the registration paperwork packet. I understand that should myself or my child fail to comply with the rules listed in the Code of Conduct, Comm Kids reserves the right to dismiss my child from the program.
10. _____ I agree as stated in the Comm Kids Code of Conduct that I will not engage in inappropriate communication either verbal or written in regards to Comm Kids programming. I

understand that if I am found to speak in a defamatory way about Comm Kids programming, staff, or other children, whether verbally or written, Comm Kids has the right to dismiss my child from the program.

I have read and agree to the terms and conditions stated above. I recognize that the Waverly Community House and Comm Kids Programs has these rules in place for the care and safety of my child, and agree to abide by them during the duration of my child's attendance at Comm Kids.
