

COMM CAMP 2020 Counselor-In-Training Application

The Counselor-In-Training (CIT) program takes place during a seven week themed day camp at The Waverly Community House that runs from June 22 – August 7, 2020. Applicants must be students entering 8th, 9th, or 10th grade in the fall of 2020. The program helps adolescents develop lifelong leadership and problem solving skills while training for a possible future position as a Comm Camp counselor.

CIT responsibilities include working with and assisting the senior counselors with daily activities, field trips, and special events while also helping develop games and programming. Participants will have the opportunity to work with campers in all age groups and activities. Weekly reflections will be conducted with participants to help develop their skills as a part of their training. The CIT program will be directed by Shannon Gula, CommKids Afterschool Assistant Director.

Participation is limited. All applicants will be interviewed before being selected to participate in the CIT program. Applications will be due by Friday May 1, 2020. Interviews will be conducted during the month of May.

Payment will be due upon acceptance into the program. The fee is \$120 per week for up to four weeks and \$550 for five or more weeks. The weeks may not be prorated. All participants will be expected to attend all agreed upon weeks and failure to provide proper notice of absence may lead to excusal from the program. All participants will be asked to complete a medical form before the start of camp. Space is limited to ten participants per week. Please be sure to return your application in a timely manner as late applications will not be accepted. We look forward to meeting you!
